1. Recognition of Traditional Territory (Michael)

We acknowledge that our office is in the unceded territory of the Coast Salish Peoples, including the territories of the Musqueam, Squamish, and Tsleil-Waututh Nations and that our members live and work in unceded territories across British Columbia. We acknowledge territory and First Peoples and commit to genuine and ongoing work to forge real understanding, and to challenge the legacies of colonialism.

ACTION: Kelly will locate, and forward to Board members, a territorial acknowledgement that includes Metis and Inuit peoples.

 - b) New Board member orientation follows this meeting or as planned by participants
- 5. President's Report (Michael) -
 - a) MCFD Consultation on social work oversight will open public feedback and written submissions in mid-December and close the consultation in mid-January. They report in May. The Advocacy Circle will work with NewMode to launch a letter writing campaign by mebers
 - b) MCFD CPD & social media request on hold, following a meeting with MCFD's Dir of Child Welfare Cory Heavenor and ADM Carolyn Kamper, until Michael, Dianne, and Phyllis can meet to discuss.
 - **ACTION**: Michael will arrange a meeting after January 16, 2023 as noted above.
 - c) <u>Health Professions and Occupations Act</u> was introduced in the BC legislature, debated, and it will be passed this week.
 - The HPOAct is 645 clauses in length.
 - BCASW meeting with Ministry of Health Director of Regulation for a briefing on the HPOAct Two BCASW members have expressed concern that Health might impose vaccine mandates on regulated health professions. Both have additional concerns about boards being appointed by government rather than elected by members. They both requested that the

BCASW advocate that the profession be regulated under the current Social Workers Act under MCFD.

DECISION: That the BCASW Board continue lobbying for the inclusion of social work regulation under the Ministry of Health and the Health Professions and Occupations Act.

- d) New BC Cabinet will be announced on December 7, 2022
- e) Michael is consulting with
 - i. BCASW members in early December (see December eBulletin)
 - ii. coalition members (e.g. school of social work, BCGEU)

- f) Dianne and Michael met with Vancouver Councillor Lisa Dominato regarding motion to hire 100 police officers and 100 nurses.

ACTION: Councillor Dominato is setting up a meeting with BCASW (Dianne, Michael, and John), her Chief of Staff, and a representative for Vancouver Coastal Health when the BCASW will promote the profession in this initiative.

- g) Michael attended several BCASW meetings since the last Board meeting Finance, Advocacy, Seniors CoP, Health Advocacy, CPD, ARCA, Membership, and TN Branch
- h) Media CBC's Lindsay Bethany "<u>Where's the accountability?</u>' Families and First Nations call for full regulation of social workers"
- i) Statements <u>Health Professions and Occupations Act</u>
- j) We consulted on the BC government report "Closing gaps, reducing barriers: Expanding the response to the toxic drug and overdose crisis"
- k) Board training on Indigenous matters, decolonizing the BCASW, setting an agenda for reconciliation, etc.
 - **ACTION**: Michael and Dianne will present a proposal to the January Board meeting regarding type of training, facilitator, timing, and cost

- m) BCASW Board members, some committee chairs, and some members with expertise in ethics are meeting with CASW and Barnes Management Group to discuss the proposed code of ethics on December 13th
- 6. Executive Director's Report (Dianne) see attached report
 - a) Due diligence training

ACTION: Dianne will contact new Board members and set up a time for an introduction to the role of a BCASW Director

- 7. Treasurer & Financial Committee Report (Fiona & Dianne)
 - a) I did not yet receive any updated financials so there is not much to add to the last meeting's report.
 - b) I do know that our projected surplus will be going up due to the fact that the in-person board meeting did not happen this year. This will add approximately \$8,000 to the projected surplus of \$20,000.

ACTION: Dianne will present a draft budget to the BCASW Executive Committee on December 14, 2022

8. CASW Report (Glen)

a) The CASW Board met in Ottawa on October 22. Barbara Whitenect of New Brunswick was elected Vice-President and Glenda Webber from Newfoundland and Labrador was

- elected Treasurer. Joan Davis Whelan continues in her role as President. The Board reviewed the existing ends (goals) of the CASW in conjunction with the recommendations from the organizational review that was conducted by Barnes Management Group. A small ad hoc committee was formed to determine which recommendations can be used as the Association moves to develop a new strategic plan.
- b) An update was provided about the Code of Ethics. The plan is to have this ready for approval at the June 2023 Federation meeting which will be held in Ontario. Provincial Focus Groups will be held and BCASW Board members along with key members will participate.
- c) The Executive Director, Fred Phelps, provided information on the negotiations related to the fee formula that is assessed on each federation member group. As noted in previous reports, the decoupling of the regulatory and association functions in Alberta (effective 2023) may result in a loss of \$108,000.00 in revenue for the CASW. A number of different options are being considered such as staff layoffs and a fee assessment increase.
- d) The CASW has contracted with an organization called the Public Studio. The Public Studio will design promotional material for Social Work Week 2023 as well as additional promotional material over a two-year period. The theme for Social Work Week will be determined later this year.
- e) The Board was presented with a draft paper titled Reparations for Social Workers of African Descent. The CASW worked with Senator Wanda Bernard to look at social work's impact on the Black community and Black social workers in Canada. This process involved initial work with the Association of Black Social Workers from Nova Scotia. The draft paper was developed by Dave Este, Chris Walmsley, and Aliyah Campbell.
- f) Fred Phelps provided an update on the CASW Internationally Educated Assessment Service. The demand in this area has grown. In 2021 the CASW completed 341 reviews. Since January 1, 2022, the CASW has processed 356 applications. Ontario accounted for 168 and Alberta 45. Hong Kong applicants account for the largest group just over 45% while the second largest groups of applicants are from India (22.58%).
- g) Fred Phelps provided information on negotiations with Alberta and Quebec. The new Alberta Association is likely to join the CASW. This may also be the case with Quebec. Quebec held an organizational meeting in November. At this time there are about 600 Quebec social workers interested in forming an association. The CASW office continues to provide support. The Order has not contributed either negatively or positively.
- h) Liability Insurance that is negotiated by the CASW will likely see a small fee increase this year. This is consistent with insurance globally, which has seen increases in premiums due to an increase in disasters that affect the broader insurance industry.
- The next in-person Federation meeting is scheduled for June 10 and 11 in Toronto. The Ontario Association is hosting the first National Federation meeting since rejoining the CASW.

9. Branch Updates (Branch Reps) -

The Northern Branch continues with its regular monthly meetings. We have a slow but steady increase in attendees. During COVID we were down to as few as three members attending a meeting. Our November meeting saw nine attendees, eight in-person and one via Zoom. Chuck Fraser delivered a presentation on self-care and strategies for self-care. It

was well received by the people in attendance. Chuck is a past recipient of the Distinguished Service Award and the Bridget Moran Award. He currently works in private social work practice. In October Dalton Chiuppi spoke to our Northern Branch and talked about helping men to express their feelings. Dalton hosts a podcast in which he tries to promote more honest openness, especially among men.

The Branch has planned its annual Christmas gathering. Prior to COVID we always selected a local agency, usually a small non-profit, and we met over lunch for a light meal and made donations to the agency. This year we will meet at the Connective Support Society, a non-profit that provides transitional housing and outreach services. We've had some preliminary inquiries from UNBC Social Work students, and they may want to join us in this activity.

Peer Consultation Meetings put on hold due to low attendance. Unsure of what to do next. In October - Branch Rep met with UNBC 4th Year BSW Students at the Terrace Campus to review and encourage participation in the BCASW.

Branch Rep met with Coast Mountain College Social Service Worker Certificate students to review and encourage participation in the BCASW.

Starting preparation for the Social Work Week Activity of the UNBC Terrace Campus BSW Graduation ring ceremony.

- b) CPD (Phyllis Nash)
 - i. The AGM presentations by Kathleen Cashin & Laura Honey (Inspiring Social Worker Award) and Elizabeth Jones (BCASW Lifetime Achievement Award) were excellent.
 - ii. Thanks to John Richmond for presenting on surviving a stroke. He received excellent reviews from participants.
 - iii. CCMI workshop on Motivational Interviewing has been completed and the Trauma-Informed practice workshop is underway with 24 registrants. We are meeting with CCMI in early December to discuss content and focus for the Brief Interventions workshop.
 - iv. Tommy Spence, MSW, RSW will present a webinar on narrative therapy in February.
 - v. There are several other webinars in development including advocating with MLAs, seniors, homelessness, and hospital discharge, EMDR, two-spirited social work, and more
 - vi. We will be reaching out to social work faculty holding BCASW membership and inviting them to present a webinar
 - vii. We are sad to Jess Holtslander leave the BCASW. We thank her for her excellent work with this committee and we wish her well in her new endeavors.
- c) Membership (Kelly) –

- i. The committee met on Monday November 7th, 2022. It was Kelly's first meeting as the new Chair. Thanks to Glen, Michael, and the other committee members for their support.
- ii. The priority for the committee currently is to develop a strategy to engage with students and post-secondary institutions on student member recruitment.
- iii. There is a draft proposal in the works focusing on establishing agreements with post-secondary institutions in which all social work students become student members upon admission to their respective social work programs. This is still in development and discussion at the committee level.
 - **ACTION**: The Membership Committee will present a proposal for this initiative at the January 2023 Board meeting
- iv. The committee is pleased to see that the membership numbers continue to increase with the last count being 1,374 members currently, including 134 student members.
