The letter reads in part "We support the campaign of the BCASW in calling for regulations requiring all social workers in BC are required to be registered and in good professional standing with the BC College of Social Workers or another oversight body, and that there be no exemptions for MCFD staff or those delegated by MCFD."

Executive Director's Report April 4, 2022 BCASW Board

In review, since our last meeting

Operations: Services continue, Dianne Heath, Executive Director, working from home office, Darren Usher, Member Services Coordinator, works from the office, Monday -Thursday mornings. Kelly Guiaya, completes her practicum through UFV mid-April with BCASW.

- Database work with Guild continues. As all members will need to opt in for services, we will have a good indication of what is valued by the membership as we review our organization.
- The website was launched March 21. SEO optimization next step.
- On-going monitoring of functioning of both old databases
- New, re-activated, and lapsed members list sent to CASW and to branches
- Job and CPD postings- revenue about \$9,000 this year. About \$160,000.00 deferred revenue to this year- a healthy amount.

 action plan to reform BC's long-term care system. The proposal will be discussed with the
 Parliamentary Secretary, early April.

- Leanne Harder and colleagues working with the Family Policy, Legislation and Transformation Division, currently in the process of reviewing and modernizing BC's Family Law Act (FLA), which has not been thoroughly reviewed since it was implemented in 2013

- Researched the issue of collection of identity data:
 - The Ontario College is planning to gather identity data. To do so, they have engaged a consultant to assist them in developing policy so as to be in compliance with Ontario's Anti-Racism Act. They will call it a member census and it will be disconnected from renewals and voluntary. They will put effort into a communications strategy around this request.

Lawyers through insurance said issue was beyond scope of program- would have to hire for consultation. BC Human Right Tribunal pending.

Support for Members (1300 current)
