## President's Report BCASW Board Mtg, April 4, 2023 Michael Crawford

Thank you to Vancouver Island member David Turner for attending an MCFD consultation on oversight of social work on my behalf on January 27, 2023. David reported that most in attendance were supportive of mandatory registration for all BC social workers.

UFV practicum student Rachel Andor and I met with <u>Parliamentary Secretary for Accessibility Susie Chant</u>. Thank you to our Health Advocacy Committee and the Seniors Community of Practice for supporting the meeting with notes. We spoke about increased funding for transportation to medical appointments, continuing the COVID benefit, accessible and affordable housing, and the need for a provincial program to provide affordable assistive devices.

Rachel and I also met with <u>Minister of Mental Health and Addictions Jennifer Whiteside</u> to discuss ways our priorities regarding government responses to MHA including more attention paid to the voices of people with lived and living experience, evidence-based interventions throughout the detox, treatment, and recovery process.

Dianne and I met with BCCSW Interim Registrar Lise Beauchesne to discuss the ASWB exam, MCFD consultation, and members concerns regarding timely processing of applications to the RCSW exam. I had a private meeting with BCCSW President Jason Lam.

Dianne and I met with CASW ED Fred Phelps to discuss the NASW position on the ASWB exam. NASW has concerns that the ASWB exam is racist and are no longer supporting it. Dianne and I are meeting with the BC school of social work deans and directors at the end of April to discuss this matter.

I have spoken to three of our members and asked them to consider working with me to create a <u>Queer Community of Practice</u> for the purpose of promoting appropriate social work practice in this area, education, advocacy, and education. I'd like to move forward and establish more communities of practice in areas such as mental health and addictions, and child welfare.

I continue to attend and participate in the following <u>committees and communities of practice</u>, TN Exec, CPD, Advocacy Circle, Anti-Racism and Cultural Advocacy, Retired Social Work Group, Finance, Indigenous, Membership, and Re-organization.

<u>MCFD</u> has said they will release a "what we heard" report on their consultation on social work oversight in May 2023. In preparation for this I have been working with UFV practicum student Rachel Andor to write an updated history of our campaign to strengthen professional social work. We hope to publish this history in this spring's Perspectives.

Lastly, BC Social Work Week 2023 was a great success in large part to the work of UFV practicum student Rachel Andor, who chaired the BC Social Work Week Working Group, and Amanda Cama, who chaired the BCASW student Committee. The event by the numbers -

Treasurer's Report
BCASW Board Mtg – April 4, 2023

Financial reports have been delayed due to the new database for memberships. I have received one statement for 2023 that has not yet been reviewed for accuracy. It appears that revenues are on track with the budget. We have an unanticipated expense of \$6600 for making system changes to accommodate charging GST on webinars and other services.

The finalized year end statements for 2022 have not yet been received.

Due to the delay in receiving statements, we will defer a discussion about a further salary increase for the Coordinator, Member Services, until the next board meeting.

## **CASW Report**

The CASW Board met virtually on Friday, March 31, 2023. This was the first Board meeting since October 2022. The Executive Director, Fred Phelps, provided an operational update.

Alberta has delayed rejoining CASW as the nascent Alberta Association experienced some delays in signing members. The delay will prevent CASW from communicating with Alberta members through the regular channels. However, about 850 Alberta Social Workers have liability insurance through BMS and they will be advised of the requirement to be a member of the Alberta Association of Social Workers so that they can access the liability insurance offered through CASW.

The Quebec group of Social Workers is being supported by CASW and the New Brunswick Association. Quebec is planning to attend the Federation meeting in June and they hope to pursue CASW membership this year.

CASW held a joint conference with the National Association of Social Workers (NASW in the United States). The conference was titled Across Borders. Fred Phelps and CASW President Joan Davis-Whelan attended. NASW has a new President, Yvonne Chase, and CASW through our ED and President have made a good connection with her.

NASW and CASW have been examining the Association of Social Work Boards (ASWB) registration examinations. In the United States, pass rates for African American Social Workers and Hispanic American Social Workers are lower than the general population. NASW, CASW, and ASWB are looking at how the exams might be revised to address this.

CASW is developing a paper to promote the importance of Social Work in health care. There has been activity in health care with new funding and targeted funding. However, much of the activity is driven by Nurses and Physicians. CASW hopes to address this through development of the paper and lobbying with government to ensure that Social Work has a place at the table.

The CASW anticipates a budget surplus of about \$80,000.00 for 2022 fiscal year. This is due to two factors. The first relates to a large increase in the demand for assessment of foreign-trained Social Workers. Related to this, Ontario and Alberta have asked CASW to undertake this process for their provinces. The second factor that contributed to the surplus was a large increase in advertising revenue. The demand for posting of ads exceeded expectations. The Board approved the proposed budget for 2023-2024 in the amount of \$722,000.00. Surplus money for 2022-2023 will be allocated to Project Funds.

The Board conducted a review of the Ends that will be used to develop the new strategic plan for CASW. This process will be completed and the new strategic plan will be presented at the Federation meeting in June 2023.

The ED also provided an update on the Code of Ethics. Thirty focus groups were held across the country. The contractor is in the process of revising the proposed Code based on the focus group feedback. Once the revisions are completed the Code will be circulated to key stakeholders for further feedback. When the feedback is received, final revisions will be made and the Code will be presented for approval at the June 2023 Federation meeting.

Mayor Yu also declared that in Prince George Social Work Week would last until March 27<sup>th</sup> so he could repeat the Proclamation reading at the beginning of the City Council meeting. Beth Quesnel announced that Heather Lamb, MSW, RSW was the recipient of CASW Distinguished Service Award and Beth presented Heather with flowers from her colleagues. Heather serves as Editor of Perspectives, and she is a past Chair of the Northern Branch. Congratulations to Heather!

Branch member Chuck Fraser, MSW, RSW, said a few words and read a poem in tribute to Bridget Moran. Everyone received buttons celebrating social work, made by the youth at the Foundry in Prince George.

The Branch had excellent media coverage with newspaper articles and televised reports on the local CKPG television network. Our Vice-Chair, Kate Stanvick, BSW, RSW was interviewed, as was Heather Lamb, MSW, RSW. Beth Quesnel, MSW, appeared for a longer interview on a television news program called CKPG Today.

We have been working on operationalizing our goals for this year. They are as follows:

## A. Housing:

- Review SAFER criteria and form recommendations for how it should be updated. We will
  partner with other organizations which may already be working on this.
- Liaise with the Seniors Advocate regarding the SAFER recommendations.
- Do the research required to gather relevant data.
- See if the Seniors Community of Practice wants to partner with us on any planned activities
- Organize a webinar related to the research on discharging patients from hospital who are not housed.

B. Long-term Care (LTC): also a component of housing for which we continue advocacy and involvement with ARRCBC.

- Continue collaboration with ARRCBC.
- Keep social workers and the public concerned about LTC issues. Respond to news stories in a timely manner when able.

- Amplify the public education work that ARRCBC is doing.
- C. As able/timely, we want to also address Toxic drug supply and MAID
  - Look for opportunities to ally with other groups working on the toxic drug supply issue (ex. Attend rallies as supporters)
  - No specific plans related to MAID at this time
- D. Continue advocacy regarding Regulation and College Consolidation.
  - Continue to support BCASW's position on regulation

Dr. Shirley Chau's lunch time presentation was great, and we hope to conduct a longer workshop in the future.
