## Student Networking Event to learn from local social workers! One profession, many roles!! Highlights of Report Submitted by Charla Anderson,

BCASW Student Representative & Networking Event Organizer



On Feb 2nd, the Thirsty Moose pub at UNBC hosted the social work student networking event. It was a great success!!! The Northern Branch BC Association of Social Workers (BCASW) Chair - Kayla Walker and Vice Chair - Marly Whitmer were both in attendance as was Dr. Standish, the Vice Provost Graduate and Postdoctoral Studies. The Northern BCASW Branch and the UNBC School of Social Work provided free appetizers. During the event, students and local social workers had the opportunity to connect with each other. Every 10 minutes students alternated between tables at which the social work professionals were seated (sometimes known as "speed dating"). Some social workers brought handouts and prizes to give away. In the end, the students shared that they were surprised by how much they learned and appreciated the opportunity to connect with local professionals.

Feedback from volunteer social work professionals was also very positive, with all indicating that they enjoyed meeting the students and learning about students' journeys while sharing their own. Every volunteer said they'd like to do it again next year, and a couple said they'd appreciate knowing about other volunteer opportunities with the Northern Branch of the BCASW.

Students also shared that they got a better idea of where they want to do their practicum. Others shared they didn't realize how many different opportunities and varieties of social work practice were available in our northern communities. Some asked for even more professionals next year, and a couple said they were interested in attending the Branch meetings, while others who can't attend, said they would look for posters for BCASW events on the Branch's social media pages and emails.

# BC Association of Social Workers – Northern Branch Bridget Moran Advancement of Social Work in Northern Communities Award Criteria & Application Form

Nomination deadline: February 26, 2024

The Bridget Moran Advancement of Social Work in Northern Communities award honours one individual who has contributed to the advancement of social work ideals. One award will be granted to the nominee who best fits the criteria. A panel of social workers will choose from nominations submitted by their peers and/or other involved parties. As a guide, the panel will use the purpose of social work, condensed below from the BCASW Code of Ethics.

Social work is a profession committed to the goal of effecting social change. Advancement toward this purpose is achieved through complementarity of social reform and therapeutic approaches. The functions of social work include helping people to develop problem-solving skills; enhancing self-determination; and advocating, promoting and acting to obtain a social justice. The criteria for eligible nominees are:

- 1. Minimum requirement is a Bachelor of Social Work degree;
- 2. Is a northern social worker and a member of the BC Association of Social Workers;
- 3. Actively promotes the practice of social work and advocates for the profession of social work;
- 4. Maintains consistently high standard for social work practice;
- 5. Unique and timely demonstration for why this award should be presented to this nominee this year, noting nominee's achievements in the advancement of social work in northern communities with particular emphasis on social justice aspects.

**Please note:** Those BCASW members who have previously been nominated and received the Bridget Moran Award may be nominated only if a minimum of 5 years has passed since the previous nomination for and receipt of the Bridget Moran Award.

This award will be presented during Social Work Week at a luncheon 11:30am to 1pm on March 13<sup>th</sup>. (Watch for future communication about details regarding the luncheon and other Social Work Week activities).
